Candidates should possess the prescribed qualifications as on the date of this notification, and should have also qualified (himself/herself) in the National Eligibility Test in the subject concerned. The candidates who have appeared for the NET examination during the year 2008 can also apply for the post. But they should produce the NET qualifying certificate at the time of interview compulsorily.

QUALIFICATIONS

- i. A Bachelor's degree in Food Technology/Food Science/Agri.Engineering/Dairy Technology/Agriculture/Home Science.
- ii. A Master's degree in Food Technology/Food Science & Technology /M.Tech. in Food Technology/ Food Engineering/Dairy & Food Engineering/Post Harvest Engineering/ Agricultural Process Engineering with atleast 55% marks or its equivalent grade.
- iii. Should have passed SSC examination or any other equivalent examination with Telugu as one of the subjects or should have studied SSC through the medium of Telugu or should have working knowledge of Telugu. Relaxable in the case of inservice teachers of APHU.
- iv. NET qualification in the concerned discipline is essential.

Selected candidate shall be governed by A.P.Horticultural University (Conditions of Service) Statutes 2007 and he/she is eligible for new Contributory Pension Scheme of the University and such other conditions as may be prescribed by the University from time to time. The selected candidate is liable to be posted or transferred to any equivalent post in the State in the same subject (discipline) in Teaching, Research or Extension under the University.

The University reserves the right not to fill the vacancy notified. for sale of applications is **17.8.2009**. The University is not responsible for late receipt of applications due to postal delay.

GENERAL INFORMATION

1. The applicant should furnish the Medical Certificate from appropriate authority to which category they belongs for their handicapping.
2. The discipline to which the Ph.D. degree belongs to shall be decided based on the research work carried out by the candidate for his/her degree.
3. For reckoning the required experience for the post, the experience in the concerned subject or discipline in teaching or extension or research shall only be considered as relevant experience.
4. NET qualification is essential for appointment to the post of Assistant Professor (Food Science & Technology) or its equivalent post as per the clarification given by UGC/ICAR vide D.O.Lr.No.6-6/2005-Acdn (Edn), Dated 23-8-2005 of the Secretary & Director General, GOI, Ministry of Agriculture and ICAR, New Delhi.
5. Certified copies of degree or provisional certificates and marks sheet/Transcripts should be enclosed to the application. The originals shall be brought at the time of interview.
6. The Registration fee may be sent through Demand Draft through a crossed demand draft in favour of COMPTROLLER, A.P.HORTICULTURAL UNIVERSITY, VENKATRAMANNAGUDEM payable at TADEPALLIGUDEM, West Godavari district, Andhra Pradesh on any Nationalized Bank. NO MONEY ORDER/POSTAL ORDER SHALL BE ENTERTAINED.
7. While filling up of the application form part 'B'.
 - i. Under item No.2 (meant for details of qualifications) the period of studies should be indicated clearly with date, month and year of joining and leaving studies. If any of the applicants did their M.Sc. or Ph.D. by research, it should be clearly indicated.
 - ii. Under item No.6 (meant for employment record) the details of service rendered by the applicant in different cadres with date, month and year of appointment and scale of pay drawn. The period of study during the service should be indicated clearly.
 - iii. Service rendered outside APHU if any should be clearly indicated.
 - iv. A certificate showing proof of service/experience outside APHU should be enclosed.
 - v. Enclose 5 sets of Research Publications.
8. The applicants should appear for interview when called at their own cost.
